As these programs are developed, EPA and other agencies will continue to seek online public comments to support the development of these funding programs. Many thanks to those who have provided or will provide public comments!



# EPA Awards More Than \$2.49M to Small Business to Develop Innovative Technologies

Six of the businesses funded are from EPA Region 9, including four Zero Waste projects. The Zero Waste projects will research:

- artificial intelligence for organics collection compliance under SB 1383
- microplastics identification and in-water floating debris removal system
- methane emissions monitoring and remote sensing,
- reducing food waste with biopreservative ingredients and smart food storage systems
- geospatial circular economy platform
- real time construction and demolition debris recycling measurement
- regional packaging reuse strategies, and
- digital verification of recycled content in plastic products.

# EPA Seeks Input on Inflation Reduction Act Programs to Reduce Greenhouse Gas Emissions Associated with Construction Materials and Products (Embodied Carbon)

EPA is seeking public input on new programs focused on lower carbon construction materials made possible by a \$350 million investment from President Biden's Inflation Reduction Act. The new programs will provide grants, technical assistance, and tools to help states and Tribal Nations, manufacturers, institutional buyers, real estate developers, builders, and others measure, report, and substantially lower the levels of embodied carbon and other greenhouse gas emissions associated with the production, use, and disposal of construction materials and products.

# **EPA Solid Waste Infrastructure for Recycling and Recycling Education Grants for Political Subdivisions of States and Territories (Local Government)**

Funding for projects that are designed to build and transform solid waste infrastructure -- including Municipal Solid Waste and Construction and Demolition Debris -- equitably reduce waste and manage materials to achieve a circular economy, reduce greenhouse gas emissions, and create cleaner, resilient, and healthier communities. The EPA also recognizes and encourages applications that demonstrate innovative solutions and programs that provide or increase access to prevention, reuse, recycling, anaerobic digestion, and composting opportunities in areas that currently do not have access. In addition, the EPA is seeking post-consumer materials management projects that address environmental justice concerns.

**Eligibility:** Cities, towns, parishes, and similar units of governments that have executive and legislative functions (see full RFA for details)

**Funding Available:** \$40 million total; \$4 million award ceiling and \$500,000 award floor. No matching funds required.

# **EPA Solid Waste Infrastructure for Recycling Grants for Tribes and Intertribal Consortia**

These grants will provide funds for tribes and intertribal consortia to develop or update plans focused on encouraging environmentally sound post-consumer materials management; establish, increase, or expand materials management infrastructure, utilize funds for equipment and construction related costs as part of their implementation plans, and identify, establish, or improve end-markets for the use of recycled materials. Funding also be used for projects that improve materials management and infrastructure, including collection, transport, systems, and processes related to post-use materials that can be recovered, reused, recycled, repaired, refurbished, or composted.

**Eligibility:** Federally Recognized Tribes, which include Alaskan Native Villages as defined in Public Law 92-203, and former Indian reservations in Oklahoma, as determined by the Secretary of the Interior, and Intertribal consortia, consistent with the requirements in 40 CR 35.504(a)

**Funding Available:** \$40 million total; award ceiling \$1.5 million and \$100,000 award floor. No matching funds required.

### **EPA Consumer Recycling Education and Outreach Grants**

Funding for consumer education and outreach related to commonly recycled materials, such as aluminum and steel containers, glass, cardboard paper and plastics, as well as food, organics (yard and tree trimmings, wood, etc.), textiles, batteries and electronics. Education and outreach activities that prevent or reduce waste by reducing, reusing, repairing, refurbishing, remanufacturing, recycling, composting or using anaerobic digestor systems to treat these types of materials or to reduce related contamination. See full RFA for eligible activities.

**Eligibility:** U.S. State, including the District of Columbia; Puerto Rico, Virgin Islands, Guam, American Samoa, Commonwealth of Northern Mariana Islands, and any agency or instrumentality thereof exclusive of local governments; a unit of local government as defined in the Local government provision of 2 CFR 200.1; an Indian Tribe; a Native Hawaiian organization; the Department of Hawaiian Home Lands; the Office of Hawaiian Affairs; a nonprofit organization; or a public-private partnership

**Funding Available:** \$30 million nationally; \$2 million award ceiling and \$250,000 award floor. No matching funds required.

# **EPA Environmental Justice Collaborative Problem Solving (EJCPS) Grants**

EPA's EJCPS Program working on or planning to work on projects to address local environmental and/or public health issues in their communities. The program assists recipients in building collaborative partnerships with other stakeholders (e.g., local businesses and industry, local government, medical service providers, academia, etc.) to develop solutions that

will significantly address environmental and/or public health issues at the local level. EPA will give special consideration to the following focus areas:

- Projects addressing climate change, disaster resiliency, and/or emergency preparedness
- Projects located in and/or benefitting rural areas
- Projects conducting <u>Health Impact Assessments (HIA)</u>

Eligibility: Community-based nonprofit organizations (and partnerships of these organizations)

**Funding Available:** \$30 million total with \$5 million reserved for small community-based nonprofit organizations with five or fewer employees; EPA anticipates 50 awards of 500,00 0 and 30 awards of \$150,000.

#### **EPA Environmental Government-to-Government (EJG2G) Grants**

The EJG2G Program works to support and/or create model state activities that lead to measurable environmental or public health results in communities disproportionately burdened by environmental harms and risks. These models should leverage or utilize existing resources or assets of state agencies to develop key tools and processes that integrate environmental justice considerations into state governments and government programs. EPA will give special consideration to the following focus areas:

- Projects addressing climate change, disaster resiliency, and/or emergency preparedness
- Projects located in and/or benefitting rural areas
- Projects conducting <u>Health Impact Assessments (HIA)</u>

**Funding Available/Eligibility:** \$70 million total, of this – \$20 million will be for State governments to be used in conjunction with Community-Based Organization (CBO) partners, \$20 million will be for local government with CBO partners, \$20 million will be for Federally Recognized Tribal Nations with CBO partners, and \$10 million will be for U.S. territories and remote tribes with limited access to CBO partners. EPA anticipates funding approximately 70 projects of up to \$1 million each for a 3-year project.

# Department of Health and Human Services, Administration for Native Americans. Environmental Regulatory Enhancement Program

This program is designed to support projects that plan, develop, and implement initiatives

designed to improve the capability of the governing body of an Indian tribe to regulate environmental quality pursuant to federal and tribal environmental laws. The ERE program enhances the ability of tribal governments to provide effective stewardship over the lands, water, and air that encompass their Native communities.

Projects must follow tribal cultural preservation and natural resource management priorities to achieve environmentally healthy and sustainable American Indian/Alaska Native communities and support locally designed projects that strengthen environmental regulatory programs in a manner consistent with the goals of tribal and Alaska Native communities.

The solicitation provides an Example Project Goal: To develop a community recycling program with a Community Recycling Awareness Action Plan that enrolls households into the program and increases participation in recycling.

**Funding Available:** \$2 million total funding, individual grants from \$100,000-\$300,000; a 20% match of federal funding with cash or in-kind contributions is required, but applicants may request a need-based match waiver

Eligibility: Federally-recognized Indian tribes, as recognized by the Bureau of Indian Affairs (BIA); Incorporated non-federally recognized tribes; Incorporated state-recognized Indian ribes; Non-profit Alaska Native community entities or tribal governing bodies (Indian Reorganization Act (IRA) or traditional councils) as recognized by the BIA; Non-profit Alaska Native Regional Associations and/or Corporations with village specific projects; Other tribal or village organizations or consortia of Indian tribes; or Tribal governing bodies (IRA or traditional councils) as recognized by the BIA
