INCIDENT LOCATION: Port William, Southern end of Shuyak Island, approximately 49 miles NNW of the city of

Kodiak

TIME/DATE OF SPILL: The incident occurred at approximately 8:00 a.m. on February 26, 2018.

HOW/WHEN SPILL WAS DISCOVERED AND REPORTED: A caretaker on site reported the spill to the National Response Center at approximately 4:00 p.m. on February 26, 2018.

TYPE/AMOUNT OF PRODUCT SPILLED: Up to 3,000 gallons of Fuel Oil No. 6 (Bunker C).

CAUSE OF SPILL: It was previously reported that wind gusts exceeding 80 mph pushed a building with the fuel bladder off a dock, causing the 3,000 gallon capacity fuel bladder to rupture and release its contents. Upon further investigation it has been determined that the dock structure supporting the building collapsed. This caused much of the building, along with the fuel bladder, to fall to the shoreline and water below.

SOURCE CONTROL: The entire contents of the bladder are suspected to have been released. Alaska Chadux will deploy swift water boom across the bay's entrance and retrieve the bladder with any remaining contents upon arrival.

RESPONSE ACTION: The United States Coast Guard has accessed the Oil Spill Liability Trust fund and has contracted with Alaska Chadux, LLC for cleanup operations. Alaska Chadux deployed 10 personnel to Kodiak. They are currently loading response vessels and mobilizing to the spill site. After a two day delay due to weather, three vessels with response personnel and equipment left the Kodiak Harbor at 7:00 a.m. this morning en route to the spill site. They are expected to arrive early evening, depending on weather. One of the objectives of response crews is to locate the bladder and remove any contents, if it is safe to do so. There have been three reconnaissance overflights of the area since the incident occurred. The most recent overflight left Anchorage at 9:00 this morning. Information from that overflight is not yet available.

RESOURCES AT RISK OR AFFECTED: The surrounding area supports northern sea otters and Steller sea lions, both are ESA listed populations and may occur throughout the area. Additionally, the area is designated as critical habitat for both species. Eagles, waterfowl, and seabirds are likely present. Pacific halibut, pacific cod, walleye pollock, and pacific herring are present in surrounding waters.

FUTURE PLANS AND RECOMMENDATIONS: ADEC is working within the Unified Command structure to assess the extent of impacts and mitigate spill impacts. Response measures will be refined when initial reconnaissance reports are received.

WEATHER: 33°F, WNW wind 20 kts becoming NW 30 kts in the evening. Seas 6-8 ft. Near the spill site the marine forecast for today and tomorrow calls for N or WNW winds from 5 to 10 kts with seas 1 to 2 feet. Saturday calls for variable winds 5 kt or less with a chance of snow before 9 am with seas around 1 ft. Saturday night calls for NW wind 5 to 15 kt, partly cloudy skies, with seas 2 to 3 ft.
