

Developing an Alaska Wetland Program Plan



Prior State Wetland Program Work

- Draft regulations with the U.S. Army Corps of Engineers (Corps) in 1993
- Hydrogeomorphic functional assessment guidebooks in the late 1990's and early 2000's
- Discussed development of programmatic general permits with the Corps in 2004
- Pursued primacy of Clean Water Act §402 2003 2008

Elements of a Wetland Program Plan

- A voluntary plan that describes overall program goals, broad-based actions, and specific activities to achieve the goals.
- EPA's basis for review is consistency with the Core Elements Framework.
 - 1. Monitoring and assessment
 - 2. Regulation
 - 3. Voluntary restoration and protection
 - 4. Water quality standards for wetlands

Elements of a Wetland Program Plan

- 1. Monitoring and assessment
 - Objectives, strategies, and long-term environmental outcomes
 - Indicators of wetland condition or function
- 2. Regulation
 - Clear, comprehensive jurisdictional coverage
 - ID regulated activities; public guidance
- 3. Voluntary restoration and protection
 - Consistent/compatible goals across agencies
 - Guidance on restoration, management and success measures
- 4. Water quality standards for wetlands
 - Develop/ adopt wetlands definition

Alaska's Path to a Wetlands Program Plan

1. Funding – Wetlands Program Development Grant

2. Partnership

- Department of Environmental Conservation (DEC) to lead state agency work group with staff from Departments of Natural Resources (DNR), Fish and Game (ADFG) and Transportation and Public Facilities (DOT)
- Workshop opportunity to identify and engage with federal agencies, local & tribal governments, and other stakeholders

3. Building knowledge

- Contractor support to research other state approaches
- Workshop with invited speakers, open to public
- Opportunity for public comment
- Summary report posted to web
- 4. Submit WPP to EPA
