## Surface Oiling Permit Application Information

### Important information about Surface Oiling

- Application of oil, asphalt, bitumen, or a residuary product of petroleum in Alaska requires an approved surface oiling permit from the Alaska Department of Environmental Conservation (department) [18 AAC 75.700(a)].
- Receiving a surface oiling permit from the department does not relieve the applicant from obtaining required permits and approvals from other divisions of the department, local, State, or federal agencies.
- The use of oil that contains any hazardous waste regulated under State of Alaska's Hazardous Waste Regulations (18 AAC 62) or any of the components and concentrations listed in 18 AAC 75.720(a)(1)-(4) is prohibited.
- Non-petroleum materials used for dust suppressant are not regulated under 18 AAC 75 but may be regulated under State of Alaska's Air Quality regulation (18 AAC 50).
- Exemptions to surface oiling permit requirements are detailed in 18 AAC 75.710.
- The applicant is required to use technology that ensures the application of the product meets the terms and conditions of the issued permit.
- Dust retardants allowed for application under the terms of a surface oiling permit are asphalt, asphalt emulsions, cutback asphalts, asphaltic oils, bituminous treatments, and the following petroleum products: crude oil, hydraulic fluids, waste lubricating oil, and emulsified oil mixtures containing these products. In some cases, a new or unknown product is proposed for use in a surface oiling operation. In this situation, the department may require analytical sampling be completed. If you are first time applicant, or if you are using a new product, please contact the department prior to submitting your application to discuss the product. Please be advised that it could take the department additional time to review the product and conclude whether it is permitted for surface oiling applications.
