



Home Heating Oil Tank Response Funding Eligibility and Application

The DEC approved application serves as the funding agreement.

As the property owner where a spill occurred from a heating oil tank system you are financially responsible for the investigation and cleanup under AS 46.03.822. State statutes and regulations require the responsible party to immediately take actions to contain and control the spill and perform a cleanup and dispose of contaminated material under a DEC approved plan.

The home heating oil tank (HHOT) response funding is available from the DEC Prevention, Preparedness and Response Program (PPRP) to support the purchase of oil sorbents, personal protective equipment, and the treatment or transport and disposal of contaminated soil. The response funding is limited to a two-year window after funding for a site is approved, until DEC fully expends the funds appropriated for this program by the Alaska State Legislature, or until June 1, 2030, whichever comes first.

Complete this application and return it to your assigned PPRP case manager. Once this form has been approved it will also serve as the agreement to provide, where approved, funding for response and cleanup materials. This funding agreement doesn't eliminate the need to develop a spill cleanup plan per 18 AAC 75.310. All response actions must be conducted under a DEC approved spill cleanup plan.

Home Heating Oil Tank Response Funding Eligibility and Application

The DEC approved application serves as the funding agreement.

Allowable uses and dollar limits:

The funding can be used for the transportation and disposal of contaminated soil and sorbents at a permitted facility. Funding for this purpose is capped at \$10,000 if the spill site is on the road system within 200 road miles of a disposal facility or \$14,000 if the spill site is off the road system or more than 200 road miles from a disposal facility.

This funding can also be used to purchase sorbents, personal protective equipment (PPE), and supplies to address vapor intrusion in living spaces and landfarming/landspreading soil treatment. DEC will provide additional funding up to \$3,000 for these supplies.

Items and types of items that are presumptively approvable: sorbent boom, pads, or sweep; heavy-duty contractor garbage bags; rubber or nitrile gloves; visqueen, heavy-duty tarps or vapor barriers; crawl space fans; buckets or supersacks; third party transport of contaminated soil such as via truck or dump truck; disposal of petroleum contaminated soil at a DEC approved facility.

Items and type of items that are presumptively not approvable: food or drink purchased for use during cleanup, cost of fuel to travel to and from response site, housing for you or others during cleanup, or hourly wage for yourself or others to conduct cleanup actions.

Purchase process:

Once your application is approved, your PPRP case manager will directly purchase supplies or pay for transport and disposal of contaminated soil and supplies by paying invoices online or over the phone with the vendor. Your PPRP case manager can assist in sourcing supplies from vendors that will ship to your community, or you can identify local vendors that carry the supplies. Your PPRP case manager will confirm all supplies are appropriate under this agreement and relevant to work approved under the DEC approved cleanup plan prior to purchasing the supplies.

Responsibility for Cleanup:

State funding under this agreement is available for 2 years from the date of State On-Scene Coordinator approval, until June 1, 2030, or until DEC fully expends the funds allocated by the Alaska Legislature, whichever comes first. **A condition of this funding is the commitment to complete free oil recovery and, at a minimum, initial soil removal within 2 years of DEC approval of this application.** Failure to complete this work will result in DEC recouping spent costs through cost recovery under AS 46.08.070.

Failing to reach closure within the financial limits of the HHOT response funding does not alleviate the property owner's responsibility to conduct an adequate response under 18 AAC 75 Article 3. If the program funds are depleted before reaching site cleanup under

18 AAC 75.315 the property owner will be expected to continue to work with SPAR to reach cleanup under 18 AAC 75.315 or 18 AAC 75.325. This technical support will be eligible for the HHOT cost recovery waiver under AS46.08.070(e) as long as the conditions continue to be met.
