

Instructions
SOC Monitoring Waiver Renewal Application
2023-2025

Your water system is eligible for the 2023-2025 SOC Monitoring Waiver Renewal if it:

- Received a SOC Monitoring Waiver (New or Renewal) within the last two waiver cycles, **AND**
- Has no changes to the Waiver Review Area (WRA), caused by the increased water usage of more than 20% or the use of new synthetic organic chemicals in the WRA.

The 2022-2025 SOC Monitoring Renewal can be completed by submitting this form or by applying directly online here: <http://dec.alaska.gov/Applications/EH/DWPayments/SOCWaivers/Info/>

Under ACC 80.1910 (a)(6)(C), the processing fee for SOC Monitoring Waiver Renewals meeting the above criteria is \$99. The processing fee is per active non-emergency source. Non-emergency sources are classified as permanent, seasonal, or backup. **The total processing fee due for each water system depends on the number of active non-emergency sources the water system has.**

If you are unsure of the number of active non-emergency sources associated with your water system, review Drinking Water Watch at: <https://dec.alaska.gov/dww/> or contact the Drinking Water Compliance and Monitoring staff assigned to your water system

If your public water system **has added a new source (well or intake)** since the 2020-2022 SOC Monitoring Cycle, a new SOC Monitoring Waiver must be completed for the new source. In addition to submitting the new SOC Monitoring Waiver application for the new source, a SOC Monitoring Renewal Application and processing fee should be submitted for the older sources.

All 2023-2025 SOC Monitoring Waiver Renewal Applications must be submitted to DEC by September 30, 2024. This deadline is to allow the Department time to review the application(s) before the end of the first quarter of 2025. If received after this deadline, a sampling violation may be issued if no sampling has occurred.

I am requesting that DEC renew my SOC Monitoring Waiver for the 2023-2025 compliance period and hereby attest that:

- 1.) I have reviewed my Initial or Original SOC Monitoring Waiver application.
- 2.) The water system continues to use the same water source(s);
- 3.) There have been no changes in the location of the well(s) or water source intake(s), and the general characteristics of the water source(s) remain the same;
- 4.) The amount of water used each year and/or the number of people using the water system remains the same. *(If more than 20% change in population or water usage, contact DEC to further discuss the impact of these changes prior to submitting this renewal form);*
- 5.) No new regulated SOC's have been introduced within the Waiver Review Area (WRA).
- 6.) I understand that the WRA will be based on Zone A of the Source Water Assessment delineated protection area. If Zone A encompasses the entire watershed, DEC staff will delineate a fixed radius WRA. The WRA will not be the same as the one in the original SOC Monitoring Waiver Application;
- 7.) I understand the SOC susceptibility from potential contaminant sources or activities will be determined by the Source Water Assessment contaminant source inventory. I also understand that if the potential contaminant sources or activities are found within the WRA, I will be given an opportunity to verify their presence before the renewal is denied.
- 8.) I understand that if the renewal application is denied, the application processing fee will not be refunded and that subsequent monitoring for synthetic organic chemicals will be required.
- 9.) I understand that under AAC 18 AAC 80.1900 (b) this monitoring waiver may be denied/revoked at any time if it is determined false information was knowingly provided.
- 10.) The above statements are true to the best of my knowledge.
