DATE/TIME OF DISTRIBUTION: January 25th, 2026, at 5:00 p.m.

POTENTIAL RESPONSIBLE PARTY (PRP): Doyon Drilling, Inc.

INCIDENT LOCATION: Western North Slope (WNS) adjacent to a gravel road about 6.5 miles northwest of Nuiqsut. GPS coordinates: 70.303724, -151.145293

DATE/TIME OF SPILL: January 23, 2026, at 4:40 p.m.

HOW/WHEN SPILL WAS DISCOVERED AND REPORTED: During a rig move along a gravel road, the Rig 26 self-propelled drilling module left the road and toppled onto the tundra.

TYPE/AMOUNT OF PRODUCT SPILLED: According to the Spill Prevention, Control, and Countermeasure Plan (SPCC) for Rig 26, the maximum potential product on board was 8,400 gallons of diesel, 1,930 gallons hydraulic oil, and 85 gallons of ethylene glycol. Because diesel was used to fuel the rig's mobilization, it is estimated that a significant portion of the diesel had been consumed prior to Rig 26 leaving the roadway. Fuel volumes in the diesel tanks were measured approximately 30 minutes prior to the incident indicating that approximately 4,000 gallons were on board. Evidence of a diesel spill has been confirmed by emergency responders; however, further assessments are in progress.

CAUSE OF SPILL: The cause of the accident is unknown. Investigation will begin when safe to do so.

SOURCE CONTROL: Source control is being determined. No ongoing leaks are observed.

RESPONSE ACTION: The response continues to prioritize the safety of all personnel first and foremost. Minor injuries were reported with eight personnel treated on the North Slope and released. Initial response actions were taken to address a fire onboard Rig 26. The site was released by the on-scene Fire Chief Saturday at 3:45 p.m., though structural hazards continue to limit access. A safety team has been dispatched to evaluate concerns.

RESOURCES AT RISK OR AFFECTED: The drilling module landed on tundra covered in 12 to 24 inches of snow. The closest oil and gas infrastructure is located approximately 50 feet away and was not impacted. Based on available maps, the site is less than 500 feet of a tributary to the Nekhelik Channel of the Colville River. The spill area lies within critical habitat for denning and non-denning polar bears and habitat for caribou, Arctic fox, muskox, and ptarmigan, but no impacts to wildlife have been reported.

FUTURE PLANS AND RECOMMENDATIONS: As safety allows, spilled products are being identified, delineated, and addressed.

WEATHER: Today: -15 °F with northwest surface winds of 10 mph.

Tomorrow: dropping to -25 to -30 °F with light snow accumulation and wind chills as low as -60 °F.
