



# Air Quality Rural Air Pollution Monitoring

- Non-regulatory, baseline ambient monitoring, wildfire smoke monitoring service
- Designed for baseline air quality data collection in 32 locations across Alaska
- Grant funded hardware
- Budget not final, was in Governor's proposal and Legislature's transmittal
- Central Data Network and publicly available information
- People can make their own health-based decisions wildfire smoke
- Ties in existing sites and can grow with additional monitors





# Air Quality Donlin Permitting

- Finalizing Response to Comment on Prevention of Significant Deterioration Construction Permit
- We received one comment from Calista, one from US EPA
- Minor changes to analysis
- No future permitting forecast yet



# Air Quality Willow Permitting

- Conoco Philips (CPAI) Willow Air Quality Permitting
- Anticipate small, distributed power and well design sent to Alpine for processing
- Minor permits, 130 day issuance target
- Public comment six to nine months out



# Air Quality Nuiqsut Data Review

- ADEC hosts Conoco VOC monitoring at their site in Nuiqsut
- Typically, Conoco releases their annual monitoring report
- We are currently reviewing their data for 2022, report would follow



# Air Quality IRA Grants

- Inflation Reduction Act, Air Pollution Reduction & GHG Reduction funds
- Climate Pollution Reduction Grants (CPRG)
- Competitive Grant Process for eligible tribes and communities – late 2023
- ADEC partnered with Alaska Municipal League to administer
- Need not be an AML member

# Environmental Health - Drinking Water

- \$6.8 million awarded by EPA Tribal Grants
  - Assist Alaska Native Villages and disadvantaged communities with completion of lead service line inventories of public water systems.
- \$494,000 dollars awarded by EPA Tribal Grants
  - Conduct sampling for PFAS compounds in drinking water of 193 Alaska Native Villages that utilize community water systems.

# Environmental Health - State Veterinarian

- Avian Influenza (HPAI H5N1) outbreak continues to be found in wild birds, domestic poultry, and some wild mammals.
- Public reports are <u>critical</u> for illness or death, please contact:
  - State Veterinarian (907)375-8215 (domestic)
  - USFWS (866)527-3358 (wild flocks)



# Environmental Health -Laboratory

- Collaboration with the Knik Tribe to support testing for Paralytic Shellfish Poisoning (PSP)
  - Knik Tribe is conducting weekly blue mussel sampling at Akutan, Chignik Lagoon, Juneau, King Cove, Kodiak, and Sand Point.
  - Samples are being analyzed at the EH Laboratory in Anchorage using FDA approved methods.

- Work with ANCs and Tribes on characterization and cleanup of contaminated sites throughout Alaska.
- Recently participated in Restoration Advisory Boards in Galena and Unalaska.
- Work with tribal governments on 11 Native American Lands Environmental Mitigation Program (NALEMP) projects to clean up environmental impacts from military activities.
- Developing ANCSA Contaminated Lands Program focusing on site verification and oversight for assessment and cleanup.
- Participated in ANTHC Partnership Group meeting on ANCSA contaminated lands.
- Conducting site-specific services through DEC's Brownfields Assessment and Cleanup (DBAC) Program. Grant application ended in February with 13 applications. Work to be conducted this upcoming field season.
- Provided Tribal Response Program Outreach and Training at ATCEM.


