## NOTICE OF INFORMAL COMMENT PERIOD ON AIR QUALITY REGULATIONS (18 AAC 50)

## FROM THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION

**BRIEF DESCRIPTION**: The Department of Environmental Conservation (DEC) is opening an informal comment period to gather public input on Alaska's air quality regulations, found in 18 AAC 50.

Alaska's air quality regulations set statewide rules for protecting clean air.

**COMMENTS**: DEC is requesting comments on all sections of 18 AAC 50. We want to know which regulations could be improved or clarified, and what changes might make them easier to understand and follow. This is not a formal rulemaking process—your input will help shape future decisions about how Alaska's air quality rules are refined:

- Clarify existing regulatory obligations;
- reduce costs for the public, industry, or government;
- improve or streamline procedures, application requirements, and review processes, for example reducing the time required to apply for a license, permit, or benefit;
- reduce administrative burdens;
- streamline permitting procedures;
- improve communication procedures;
- provide greater transparency with respect to standards, decision-making, and rationales for application processing; or
- clarify interagency roles.

**ADMINSTRATIVE ORDER 360**: This notice is part of Governor Dunleavy's Administrative Order 360, which directs agencies to review regulations and identify ways to make them more transparent, more efficient, and less burdensome while continuing to protect Alaskans.

**DEADLINE:** Comments must be received by **no later than 11:59 p.m. on September 26, 2025.**
