



## **Interpreting Drinking Water Sampling Results and How to Write Consumer Confidence Reports (CCRs) – Monday, March 30<sup>th</sup> and Tuesday, March 31<sup>st</sup>, 2026**

This class will meet on Monday and Tuesday March 30<sup>th</sup> and 31<sup>st</sup>, from 10:00 am to approximately 12:00 pm via zoom.

The purpose of the class is to learn how to interpret drinking water sampling results and use the data to write annual consumer confidence reports for community water systems. Consumer confidence reports (CCRs) are required each year for every water system to inform consumers about water quality.

### **Day 1**

The first day of this class introduces CCRs and why they are important. We will go over a presentation about common contaminants in surface and groundwater sources, how to interpret the sampling results and determine when they are a health concern. Then we will provide a walk through of a data dump, which is the data used to write a CCR. The iWriter tool that is used to write CCRs will be introduced.

### **Day 2**

The second day of this class begins with a data dump review that will answer any questions students have about data dumps. The rest of the class time will be spent going through an example draft of a CCR using the iWriter tool. We will close with a reminder of the CCR deadlines and a recap of the process to complete a CCR.

To take part in the course, students will need:

- Time allotted in their work schedule to attend the training.
- Use of a computer and access to internet.
- An active email address to receive documents for the course and links to Zoom classroom.
- Consistent internet access and the ability to watch/listen over Zoom.
