Subject: Correction to the Department's February 12, 2025 Approval Letter re: PSD Permit and Approval to Construct – Third Permit Extension Request dated February 10, 2025 for Alaska Gasline Development Corporation's Gas Treatment Plant, Air Quality Control Construction Permit AQ1524CPT01

Dear Mr. Richards:

In a letter dated February 12, 2025, the Alaska Department of Environmental Conservation (the Department) approved Alaska Gasline Development Corporation's (AGDC's) February 10, 2025 Third PSD Permit Extension Request to Commence Construction for the Gas Treatment Plant (GTP). However, the Department incorrectly stated in the letter that AGDC had until August 13, 2027 to commence construction, which is one year later than what a third 18-month extension would allow. **Therefore, the Department is reissuing the attached approval letter dated February 12, 2024 to correct this mistake and properly allow for the third PSD extension approval for AGDC to commence construction at the GTP no later than August 13, 2026.** This new approval letter rescinds and replaces the previously issued third extension approval letter.
