Subject: SIP Submittal of 2024 Amendments to the Fairbanks Serious SIP Regulations and Serious SIP Requirement Revisions – DEC Priority

Dear Mr. Sixkiller:

This letter provides amendments to Alaska's Air Quality Regulations in 18 AAC 50 and State Air Quality Control Plan (State Implementation Plan (SIP)) to meet the Serious nonattainment area planning requirements for the Fairbanks North Star Borough fine particulate matter (PM_{2.5}) nonattainment area, adopted by reference into Alaska Administrative Code (AAC) at 18 AAC 50.030, Air Quality Control regulations, with effective dates of December 8, 2024, and December 14, 2024. Specific provisions are submitted for EPA approval, while other provisions are included for informational purposes only, to show a complete record of the rulemaking.

On November 8, 2024, the Lt. Governor signed and filed the following changes to the Alaska Department of Environmental Conservation's (DEC) regulations in 18 AAC 50:

- Amend 18 AAC 50.030 to adopt revisions to the State Air Quality Control Plan by amending Volume III Appendix to Volume II, Section II to incorporate the proposed regulations after public review and comment. This appendix within the State Air Quality Control Plan contains the state's air quality regulations;
- Amend 18 AAC 50.055 to create an emission limit for coffee roasters in the nonattainment area;
- Amend 18 AAC 50.076 to revise requirements for dry wood labeling, frequency of wood moisture content measurement, and confirmation, as well as documentation timing of dry status;
- Amend 18 AAC 50.077 to clarify the intent of the regulation;
- Repeal and readopt 18 AAC 50.078 to create control device installation requirements; an emission factor and opacity limit; maintenance and observation requirements; and registration, recordkeeping, and reporting requirements for commercial coffee roasters in the nonattainment area;

- Amend 18 AAC 50.079 to clarify that a testing protocol required under this section must be approved by the department prior to conducting a test;
- Amend 18 AAC 50.079 to specify an allowable emission rate for particulate matter;
- Amend 18 AAC 50.079 to establish a specific duration for waivers issued under the subsection;
- Amend 18 AAC 50.079 to clarify deadlines for coal-fired heating devices;
- Amend 18 AAC 50.079 to add a new subsection adding requirements for devices that may not be reinstalled in the nonattainment area;
- Amend 18 AAC 50 to add a new section, 18 AAC 50.081, to establish real estate transaction and energy rating requirements for buildings in the nonattainment area.

On November 14, 2024, the Lt. Governor signed and filed the following changes to the Alaska Department of Environmental Conservation's (DEC) regulations in 18 AAC 50:

 - vii. amending Section III.D.7.12: Emergency Episode Plan, by amending subsection III.D.7.12.2, and Tables 7.12-1, 7.12-5, 7.12-6;
 - viii. amending Section III.7.14: Conformity and Motor Vehicle Emission Budget.
 - amending Volume III Appendix to Volume II, Sections III.D.06 – III.D.10 and III.D.14 to incorporate:
 - i. supporting documentation for proposed amended sections of the FNSB PM2.5 SIP listed above and
 - ii. Air Quality Permits issued in November 2024 that incorporate the best available control technologies (BACT) emission limits listed in FNSB PM2.5 SIP Section 7.7.13.8.2.1 and the corresponding monitoring, recordkeeping, and reporting (MR&R) requirements listed in Volume III Appendix into Volume II, Section III.D.07 for the sources listed in FNSB PM2.5 SIP Sections 7.7.13.8.3 – 7.7.13.8.7; and
 - amending Volume III Appendix to Volume II, Section II to incorporate the proposed regulations after public review and comment. This appendix within the State Air Quality Control Plan contains the state's air quality regulations.

DEC is submitting the relevant parts of the Fairbanks Serious SIP 2024 regulation revisions and SIP amendments to EPA for approval today. These revisions are intended to meet the additional planning requirements under Clean Air Act (CAA) section 189(d) and EPA's implementing
