
The proposed authorization under general permit AKG521000, Onshore Seafood Processors in Alaska, authorizes a modified effluent limit associated with the facility's temperature mixing zone and authorizes a modified project area zone of deposit (ZOD), as follows:

Modified Project Area ZOD

The permittee may exceed the water quality criteria of 18 AAC 70.020(b) for residues and the antidegradation requirement of 18 AAC 70.015 in a project area ZOD, within which the deposit of substances (residues) on the seafloor is authorized. Seafood processing waste residues are limited to a cumulative total of 1.0 acre of coverage within the project area ZOD.
