- Contested Decision – The Alaska Department of Environmental Conservation (DEC) Environmental Health Division (Division) denial of renewal for Safety Waste Medical Waste Treatment Permit #SWZA102-24.
- Location – 8050 S. Alix Drive in Wasilla, Alaska
- Background – The Alaska Department of Environmental Conservation (DEC) Environmental Health Division issued a denial for the renewal of Safety Waste Medical Waste Treatment Permit #SWZA102-24 on May 8, 2024. The Requester wishes to contest the permit denial.

As provided in 18 AAC 15.220, the Division may file a response to the request for adjudicatory hearing by serving a response on the Office of Administrative Hearings by June 25, 2024. The Requester may file a reply within seven days of service of any timely filed response to the hearing request. Written responses and replies on the request for adjudicatory hearing must be served on each party and the Office of the Commissioner as required by 18 AAC 15.340. Requester's reply may be served to the Office of Administrative Hearings by email to doa.oah@alaska.gov or by mail addressed to the Office of Administrative Hearings, P.O. Box 1101231, Juneau, AK 99811-0231, or the Office of Administrative Hearings, 550 W. Seventh Avenue, Suite 1940, Anchorage, AK 99501. The Office of Administrative Hearings will issue a recommended decision to the DEC Commissioner on whether the request meets the requirements of 18 AAC 15.200 and, if so, the scope of the proceedings before the Office of Administrative Hearings. The Commissioner or the Commissioner's designee will issue a decision on the request under 18 AAC 15.220. DEC complies with Title II of the Americans with Disabilities Act of 1990.
