INCIDENT NAME: GC-2 Tank 8511 Spill SITREP #: 6 and Final

TIME/DATE OF SPILL: The spill was discovered at approximately 10:00 AM on December 19, 2006 and reported to ADEC by BPXA at 10:25 AM.

TIME/DATE OF SITUATION REPORT: 2:00 PM December 3, 2007

TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: BPXA has estimated the spill volume at 255,152 gallons of produced water and 126 gallons of crude oil.

LOCATION: Prudhoe Bay, Western Operating Area, Gathering Center 2 (GC-2).

<u>CAUSE OF SPILL</u>: The investigation determined that the cause of the release was mechanical failure involving the agitation jets used to suspend solids near the bottom of the tank. Misalignment of a jet caused a hole to erode through the bottom of the tank.

POTENTIAL RESPONSIBLE PARTY (PRP): BPXA

RESPONSE ACTION: While the tank was releasing produced water from the hole in the bottom of the tank the crude oil was skimmed off through a drain line. Fresh water was pumped in to the tank to give the oil greater retention time to increase the effectiveness of the skimming operation. When most of the oil had been removed the tank was allowed to drain down.

BPXA used vacuum trucks to remove the produced water and crude oil from the secondary containment. The spill area was then flushed with hot water to melt the snow and ice and remove the remaining oil and produced water. The oil was returned to the pipeline and the produced water was re-injected into the formation to aid in oil production.

During this summer, BPXA repaired the torn liner of the containment area and DEC responders inspected both, the liner to ensure repairs were completed and the containment area to verify that no sheen was present.

SOURCE CONTROL: On December 23, 2006, the skimming operation was completed and the liquid level in the tank was lowered below the release point.

RESOURCES AFFECTED: Gravel pad. BPXA has estimated that one to two gallons of produced water flowed through the hole in the containment liner to the gravel pad. BPXA has not reported any impacts to tundra.

FUTURE PLANS AND RECOMMENDATIONS: None, the spill response has been completed.

WEATHER: Current weather is partly cloudy, blowing snow, temps 10 to 15 degrees F.
