RESPONSE ACTION: Peter Pan Seafood's Plant Manager notified local 911 personnel. The seafood plant was evacuated. Peter Pan's hazmat team replaced the broken valve, and secured the plant. The plant shall be reopened when air quality returns to normal.

Emergency Response Team transported five (5) plant employees to the local clinic for evaluation. Two (2) additional employees were transported to the clinic by Peter Pan personnel. According to the plant manager, none of the injuries are of a serious nature.

SOURCE CONTROL: The local HAZMAT team has secured the leak and replaced the bad valve.

RESOURCES AFFECTED: None

<u>FUTURE PLANS AND RECOMMENDATIONS:</u> The HAZMAT team will continue to monitor the atmosphere in and around the plant. When the atmosphere is deemed safe, employees will be allowed to return to work.
