TIME/DATE OF SPILL: The actual time of the spill is unknown. The vessel sinking was reported to Marine Safety Office (MSO) Anchorage on August 25, 2003 at 9:30 p.m. The MSO Anchorage reported the sinking to ADEC August 26, 2003 at 9:00 a.m.

TIME/DATE OF SITUATION REPORT: 3:30 p.m. on August 28, 2003.

TIME/DATE OF NEXT REPORT: As the situation warrants.

<u>TYPE/AMOUNT OF PRODUCT SPILLED:</u> Sheen due to diesel has been reported by the US Coast Guard (USCG). The amount lost is unknown at this time. Approximately 2,500-3,000 gallons of diesel are on onboard as per the USCG.

LOCATION: Pavlof Bay, between King Cove and Sand Point in the western Aleutian Islands.

CAUSE OF SPILL: According to the Coast Guard, the 50' fishing vessel became unstable while recovering its nets.

POTENTIAL RESPONSIBLE PARTY (PRP): Mike Stone, Seattle (owner of vessel)

RESPONSE ACTION: Magone Marine Salvage arrived on site early in the morning on August 28, 2003 and is responding to the situation.

SOURCE CONTROL: According to the Coast Guard, Salvage divers with Magone Marine have capped the fuel vents and fuel sheening has apparently stopped.

RESOURCES AFFECTED: None

<u>FUTURE PLANS AND RECOMMENDATIONS:</u> According to the Coast Guard, Magone Marine intends to have the vessel refloated sometime tomorrow, weather permitting.

WEATHER: Wind North at 6 mph, Temperature 55 ° F.
