SITUATION REPORT

INCIDENT NAME: H&H Contractors gasoline release SITREP#: 1

SPILL NUMBER: The number has been requested. **LEDGER CODE:** Not requested at this time.

TIME/DATE OF SPILL: H&H Contractors estimated the spill occurred on Wednesday, November 12, 2003 at 7:00 PM. The spill was reported to AST dispatch at approximately 7:30 AM on Thursday, November 13, 2003, who faxed the spill report to DEC this morning.

TIME/DATE OF SITUATION REPORT: 12:45 PM, November 13, 2003.

TIME/DATE OF THE NEXT REPORT: As the situation warrants.

TYPE/AMOUNT OF PRODUCT SPILLED: H&H contractors initially reported it as a spill greater than 55 gallons of gasoline. They then later revised the estimate of volume spilled to 1500 – 2800 gallons.

LOCATION: The spill occurred on Marion Drive in Fairbanks, AK. Marion Drive is a dead end street within an industrial area. Traffic in this area is generally limited to the H&H shop traffic.

CAUSE OF SPILL: A 5,000 gallon gasoline holding tank was pierced by a loader working the area.

POTENTIAL RESPONSIBLE PARTY (PRP): H&H Contractors, Inc.

RESPONSE ACTION: The area of contamination has been identified and coned off. Access has been restricted to the area. The spill impacted area is estimated at 100 by 50 feet encompassing the road and adjacent property. The snow and ice within this area has provided some containment of the spill through its natural absorption properties.

H&H Contractors has hired Inland Petroleum's vacuum truck. H&H Contractors' personnel are using the vacuum truck to pump off the remaining gasoline inside the 5,000 gallon tank and any additional free product that is discovered under the ice. Approximately 5 crew members working on the cleanup wearing personal protective gear including respirators. All safety issues are being addressed by the PRP.

An ADEC responder was on site this morning to assess the spill site and provide oversight of the response efforts.

SOURCE CONTROL: The 5000 gallon tank was elevated on one side and braced with cribbing to keep the gasoline from pouring out of the puncture.

RESOURCES AFFECTED: A 100' by 50' area of snow/ice covered asphalt and gravel road. There are no water bodies in the vicinity that could be affected by the spill.

<u>FUTURE PLANS AND RECOMMENDATIONS:</u> DEC will continue oversight of cleanup activities and work with the RP to develop a sampling and disposal plan.

WEATHER: Mostly cloudy with flurries, 0 degrees Fahrenheit
