SITUATION REPORT

INCIDENT NAME: Marathon Beaver Creek Fire SITREP #: 4

TIME/DATE OF SPILL: 6:00 PM, November 30, 2004. The incident was reported to DEC at 6:40 PM,

November 30, 2004.

TIME/DATE OF SITUATION REPORT: 3:00 PM, December 3, 2004

TIME/DATE OF THE NEXT REPORT: As the situation warrants.

<u>TYPE/AMOUNT OF PRODUCT SPILLED</u>: Produced fluids (produced water and natural gas condensate). Two 300-barrel (12,600 gallon) storage tanks were destroyed in a fire. Marathon officials estimate approximately 381 barrels (16,002 gallons) of produced fluids were released onto the pad.

LOCATION: Beaver Creek Unit, Pad 1-A, Kenai, Alaska.

CAUSE OF SPILL: Fire. The cause and source of the fire remains under investigation.

POTENTIAL RESPONSIBLE PARTY (PRP): Marathon Oil Company, Kenai AK.

RESPONSE ACTION: The release of natural gas from well 1A has been stopped. 66 barrels (2772 gallons) of 6% potassium chloride (KCl) solution was pumped into the well, effectively reducing pressure at the wellhead to zero and stopping the release. The KCl solution was pumped into the well at a safe distance from a portable tank to a flowline connected to the wellhead. Activities this morning involved pressure testing a section of the flowline and replacing needle valves on the flowline and wellhead. When the pressure testing and valve replacement was completed, and the equipment was in place to begin pumping, a well control expert from Wild Well Control, Inc. (Houston, TX) opened a valve at the wellhead. Pumping operations then began, at 12:30 pm. The KCl solution was injected at a pressure of 1200 PSI at a rate of two barrels per minute.

The capping of the natural gas well will be completed by inserting an isolation plug down the well to a depth of approximately 100 feet (below the methanol injection port), and installing a back pressure valve at the wellhead. This work is expected to be completed today.

An ADEC responder is on-scene and providing oversight. Marathon has assembled an Incident Management Team (IMT) at the CISPRI Command Post in Nikiski and the ADEC State On-Scene Coordinator is participating in the unified command.

SOURCE CONTROL: The two 300-barrel tanks were destroyed in the fire. The release of natural gas has been controlled and well capping is expected to be completed today.

RESOURCES AFFECTED: According to Marathon officials, the release of produced fluids was confined within the pad 1A berms. The pad is surrounded by a wooded area. A wetlands area is located 150 yards from the pad. There have been no reports of injured wildlife.

<u>FUTURE PLANS AND RECOMMENDATIONS</u>: A detailed site assessment will commence this weekend. Marathon will prepare site cleanup and waste disposal plans for ADEC review. A joint Marathon/ADEC investigation will be conducted to determine the cause of the fire.

WEATHER: Partly cloudy with temperatures high 20s to low 30s and NW winds at 15-30 mph.
