SITUATION REPORT

INCIDENT NAME: Drill Site 11 Methanol Release SITREP #: 3

TIME/DATE OF SPILL: The release was discovered on February 17, 2005 at 5:27 PM by BPXA personnel, and

reported to ADEC at 5:35 PM.

TIME/DATE OF SITUATION REPORT: March 14, 2005 at 2:30 PM.

TIME/DATE OF THE NEXT REPORT: As the situation warrants.

TYPE/AMOUNT OF PRODUCT SPILLED: BPXA estimates that a maximum of 1,092 gallons were spilled. The spilled material was a solution of equal parts water and methanol.

LOCATION: The release occurred at Drill Site 11, which is in the greater Prudhoe Bay oil production area. Prudhoe Bay is on the Beaufort Sea, and approximately 400 miles north of Fairbanks.

CAUSE OF SPILL: The cause of the leak in the line is under investigation, but corrosion is suspected. On March 13, 2005 the seawater line was stripped of its insulation to reveal a small pencil-tip size hole located in the noon position on the line.

POTENTIAL RESPONSIBLE PARTY (PRP): BPXA

RESPONSE ACTION: An ADEC responder is on location in Prudhoe Bay to oversee cleanup and disposal activities. A cleanup and disposal plan has been submitted to the department and approved.

The total cleanup area is estimated at 10,000 square feet. Approximately 820 cubic yards of contaminated snow have been transported to T-pad, an approved interim storage location, pending disposal at the Pad 3 waste injection facility. As of March 13, 2005, 44,730 gallons of contaminated liquid has been injected at Pad 3.

Six to 8 contract spill responders are on site executing a flushing tactic to remove any residual methanol contamination. A flushing tactic involves the use of fire hoses spraying approximately 100 degree Fahrenheit water over the spill site while a vacuum truck sucks up the free liquids.

SOURCE CONTROL: The pipe was isolated and then evacuated. No material remains in the pipeline at this time.

RESOURCES AFFECTED: The spilled material has impacted snow, ice and gravel.

<u>FUTURE PLANS AND RECOMMENDATIONS</u>: A sampling plan is expected to be drafted and submitted, to the department for review, within the next few days.

Continue the hot water flushing tactic until, by visual observation, the site appears to be free of contamination. Then execute the approved sampling plan to confirm cleanup levels have been met.

WEATHER: The National Weather Service reports that it is currently 4 degrees Fahrenheit with NE winds at 3 mph.
