<u>TIME/DATE OF SPILL</u>: Unknown, however the spill was discovered as a sheen around the wooden vessel on May 15, 2006. The spill was reported to ADEC on May 15, 2006 (revised from May 16, 2006) by the Aleknagik Village EPA Indian General Assistance Program (IGAP) Coordinator.

TIME/DATE OF SITUATION REPORT: 3:30 PM, June 05, 2006

TIME/DATE OF THE NEXT REPORT: As the situation warrants.

TYPE/AMOUNT OF PRODUCT SPILLED: Diesel fuel, unknown amount; however the PRP estimated that the release may have been at a rate of 1 gallon per hour since the discovery on May 15, 2006. The PRP is preparing a final report for ADEC review with an estimate for spill volume.

LOCATION: Approximately 2 miles downriver from Aleknagik Lake on the Wood River. The Wood River is located 16 miles northwest of Dillingham.

CAUSE OF SPILL: Is under investigation, the PRP believes the spill may have been related to the keel freezing to the river bottom and incoming tide lifting the hull off the wooden keel.

POTENTIAL RESPONSIBLE PARTY (PRP): Anna Mae Sorenson., Owner

RESPONSE ACTION: On June 5, 2006 the PRP reported to ADEC that all the remaining fuel was removed from the barge and no further oil sheening has been observed at the site. The PRP plans to decon ADEC hard boom and replace all dispensables used from the ADEC emergency spill conex in Dillingham.

SOURCE CONTROL: Successfully removed fuel from remaining non-leaking fuel tank. Engine oils from the main and auxiliary engines will be removed once engines are removed from the vessel.

RESOURCES AFFECTED: Wood River and confluence of Aleknagik Lake. There have been no reports of any impacted wildlife or recent oil sheens from the vessel.

FUTURE PLANS AND RECOMMENDATIONS: ADEC, ADNR and the USCG will review PRP's vessel removal plan. PRP is preparing a final report for agency review.

WEATHER: Today: Partly cloudy, highs in the 60s, light winds. Tuesday and Tuesday night: Partly cloudy, highs in the 60s, lows in the upper 30s to lower 40s, South winds 15 mph.
