**SITUATION REPORT**

**INCIDENT NAME:** FV Arctic Hunter Grounding

**SITREP #:** 1

**TIME/DATE OF SPILL:** 4:15 A.M. January 16, 2007. The spill was reported to ADEC by the U.S. Coast Guard Marine Safety Detachment, Unalaska at 7:30 A.M. January 16, 2007.

**TIME/DATE OF SITUATION REPORT:** 11:00 A.M. on January 16, 2007

**TIME/DATE OF THE NEXT REPORT:** 11:00 A.M on January 17, 2007

**TYPE/AMOUNT OF PRODUCT SPILLED:** The volume of the spill is unknown. The vessel operator reported that some fuel was lost out of the day-tank vent when the vessel keeled over and there was an unknown amount of oil and fuel lost from the engine room space during the de-watering process.

**LOCATION:** East Side of Hog Island, Unalaska

**CAUSE OF SPILL:** Vessel grounding; the cause of the grounding will be under investigation by the U.S. Coast Guard.

**POTENTIAL RESPONSIBLE PARTY (PRP):** Arctic Hunter LLC

**RESPONSE ACTION:** Two dewatering pumps were mobilized to the grounding location in an attempt to keep the vessel from sinking. At approximately 8:40 A.M today the fishing vessels Saratoga and Vixen assisted in refloating the Arctic Hunter and towed it to the Magone Marine facility where the vessel will be boomed and assessment of damages completed.

At 10:00 A.M. the operator reported that there was no sheen visible behind the Arctic Hunter as it was being towed from the grounding site to Magone Marine.

The Arctic Hunter is a 93-foot steel fishing vessel and at the time of the grounding the day tank contained approximately 2000 gallons of diesel. The vessel had an additional 17,000 gallons of diesel fuel stored in other tanks aboard the vessel.

**SOURCE CONTROL:** The vessel has been re-floated.

**RESOURCES AFFECTED:** Waters of Unalaska Bay and shoreline of Hog Island. No oiled wildlife has been observed.

**FUTURE PLANS AND RECOMMENDATIONS:** ADEC will continue to monitor response actions with the Coast Guard.

**WEATHER:** Overcast, South winds 25 knots increasing to 40 knots, gust to 50 knots in the afternoon, seas 3 ft. increasing to 6 ft this afternoon, rain showers.
