SITUATION REPORT

INCIDENT NAME: Davis Block & Concrete Company Truck Rollover SITREP #: 1

SPILL NUMBER: 07239918401 LEDGER CODE: Requested

<u>TIME/DATE OF SPILL</u>: According to the Alaska State Troopers, the truck rolled over at approximately 5:19 AM on Tuesday July 3, 2007. The spill was reported to the ADEC by the State Troopers at 6:30 AM.

TIME/DATE OF SITUATION REPORT: 2:00 PM, July 3, 2007.

TIME/DATE OF THE NEXT REPORT: As the situation warrants.

<u>TYPE/AMOUNT OF PRODUCT SPILLED</u>: An estimated 200 gallons of diesel fuel and 20 gallons of engine lube oil were released primarily to land with a small percentage leaking into a small unnamed pond.

LOCATION: Mile point 52 Sterling Highway Cooper Landing, Alaska.

<u>CAUSE OF SPILL</u>: A semi truck was hauling a shipment of concrete block and an empty concrete trailer north bound on the Sterling Highway from Soldotna en route to Anchorage when the driver lost control of the vehicle. The truck ran off the side of the road consequently damaging one of the fuel tanks causing it to leak.

POTENTIAL RESPONSIBLE PARTY (PRP): Davis Block & Concrete Company

RESPONSE ACTION: The semi truck had approximately 380 gallons of diesel fuel in its pair of 200 gallon capacity saddle tanks and 20 gallons of engine lube oil when it rolled over. Upon impact, one of the saddle tanks was ruptured allowing approximately 200 gallons of diesel fuel to spill onto the ground and into a small pond. Weaver Brothers responded to salvage the truck and its trailers.

Emergency response efforts thus far have recovered the truck and its trailers. An ADEC responder was on scene at 8:40 AM and placed absorbent boom in the pond as an emergency response measure.

SOURCE CONTROL: Both the truck and trailers have been secured and removed from the site. Absorbent boom has been placed in the pond at the spill site for containment.

RESOURCES AFFECTED: The area affected is approximately 20 ft x 25 ft onto the ground and into an unnamed pond. The pond empties through a culvert and into the Kenai River. No oil has flowed into the Kenai River and absorbent boom has been placed in the pond at the culvert.

<u>FUTURE PLANS AND RECOMMENDATIONS</u>: Davis Block & Concrete Company is in the process of retaining a spill response contract company to perform the cleanup which will include cleanup of the pond, excavation and treatment of the contaminated soil and disposal of the contaminated materials.

WEATHER: Mostly cloudy with scattered showers, temperatures in the 50s and winds southwest at 15 mph.
