INCIDENT NAME: ARRC Denali Park Hazmat Spill SITREP #: 2 and final

<u>TIME/DATE OF SPILL</u>: 3:30 AM on July 10, 2007. Alaska Railroad Corporation (ARRC) reported the spill to the ADEC via the Alaska State Troopers after-hours number at 5:20 AM on July 10, 2007.

TIME/DATE OF SITUATION REPORT: 11:00 AM, on July 11, 2007

TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: Non-hazardous dust control agent EK[®]35. A Fairbanks North Star Borough (FNSB) Hazmat responder estimated that approximately 5 gallons were released from the 250-gallon poly container.

LOCATION: Mile post 348 of the Alaska Railroad at Denali National Park and Preserve near the train depot.

CAUSE OF SPILL: Crack on the poly container lid.

POTENTIAL RESPONSIBLE PARTY (PRP): American Fast Freight, Inc.

RESPONSE ACTION: On July 10, 2007, an ADEC responder arrived in Denali at 11:00 AM. The rail car was already en route to Healy when the ADEC responder arrived. The FNSB Hazmat team was released before reaching Denali, by the ARRC since the packing list provided by the American Fast Freight indicated that the materials on board were non-hazardous. The ADEC SOSC requested ARRC to verify the contents in the freight container before continuing on to its final destination to ensure that the content in the car was indeed what was indicated on the packing list. The FNSB Hazmat team was recalled to meet the ARRC, American Fast Freight, and ADEC representatives in Healy.

The FNSB Hazmat team arrived on site in Healy at approximately 12:30 PM. The two Hazmat team responders entered the freight container in Level B suits. The Hazmat team found the leaking poly container in the back left corner of the freight container. The poly container had an existing crack on the lid, which was patched over with a metal tape. The dust control agent was leaking through a hole in the metal tape when the liquid would slosh from the rail car movement. The poly container is 250-gallon capacity. The Hazmat team estimated that approximately 5 gallons were lost from the container. Containers containing the lead monoxide powder on board were intact. There was no indication of incompatibility between lead monoxide and the dust control agent in the Material Safety Data Sheet.

The FNSB Hazmat team plugged the hole in the poly container lid with absorbent pad. An absorbent boom will be placed around the compromised container and sorbent pads will be placed on top of the lid with weight on top to minimize the leak during final transport to Fairbanks.

SOURCE CONTROL: Plugged the hole on the metal tape leaking to the lid-crack with absorbent pad.

RESOURCES AFFECTED: None observed. Most of the leaked dust control agent was contained within the freight container and small quantity leaked out onto the rail car flat bed.

FUTURE PLANS AND RECOMMENDATIONS: None.

WEATHER: Numerous showers, highs around 65°F and south winds 10 to 20 mph.
