<u>TYPE/AMOUNT OF PRODUCT SPILLED</u>: Potential (6,216,000 gallons or 148,000 barrels) Cook Inlet Crude, plus diesel fuels and lube oils.

LOCATION: Drift River Oil Terminal, West side Cook Inlet, 60° 36.00 N - 152° 11.00 W

<u>CAUSE OF SPILL</u>: Volcanic eruption/flooding. Mount Redoubt initially erupted on March 22, 2009 at 10:38 PM, followed by several other eruptions. The resultant lahars (or volcanic mudflows) caused extensive flooding at the Drift River Terminal. However, no oil or hazardous substance releases have been reported at this time.

POTENTIAL RESPONSIBLE PARTY (PRP): Cook Inlet Pipe Line Company (CIPL)

<u>RESPONSE ACTION</u>: As of 1:40 PM March 28, 2009 the Alaska Volcano Observatory (AVO) reported that up to eleven eruptions had occurred since yesterday evening, with one to four of these eruptions generating lahars. On March 28, 2009 at 3:29 PM, an eruption produced a 35,000 foot above-sea-level ash plume.

On the morning of March 28, the State/Federal Joint Incident Management Team (JIMT) met to discuss situation updates from AVO, ADEC, USCG and other attending IMT agencies. The JIMT reviewed and discussed each of the response objectives/strategies within the Federal/State Incident Action Plan (IAP) and discussed new issues/ concerns related to the incident objectives. An updated IAP for the next operational period is being prepared and will be posted on the State/Federal Joint Command website. (see below)

The AVO provided the JIMT with volcanic eruption updates but said that no overflights were completed yesterday due to the weather and volcano activity. AVO clarified information submitted to the JIMT from their March 27, 2009 field assessment report. AVO will be attempting to estimate the approximate extent of snow and ice melt in the upper Drift River Valley and model potential lahar and flooding effects to the down valley DROT facility.

The USCG is negotiating an earlier tanker visit to DROT for April 1; otherwise the next scheduled visit is April 4. CIPL submitted a "Restart Plan" to the US DOT/Pipeline & Hazardous Materials Safety Administration (PHMSA) for review.

The March 28 1:30 PM meeting between the USCG, ADEC, AVO, PHMSA, CIPL and Chevron continued to address the potential flooding impacts to the DROT and operational measures to avoid any damage to the facility. DNR has observed upstream channel diversion activity towards the southwest corner of the DROT containment dike and commented on potential erosive effects to the dike. DNR's comments were based on their interpretation of the overflight photos of the facility.

CIPL continues to assess the integrity of the dike system, and to move mud and debris away from the priority facilities within the terminal. CIPL stated that spring break-up conditions are complicating cleanup efforts.

<u>SOURCE CONTROL</u>: The facility and pipeline were shut down on the morning of March 23, 2009. The terminal and pipeline remain secured at this time.

<u>RESOURCES AFFECTED</u>: Drift River, Rust Slough and Redoubt Bay, Cook Inlet

FUTURE PLANS AND RECOMMENDATIONS: An overflight is scheduled this afternoon by ADEC and USCG/MSD Kenai to the DROT. The ADEC and USCG staff are planning overflights from Nikiski to complement the AVO overflights. Daily morning JIMT meetings and afternoon executive meetings between ADEC, USCG, PHMSA and CIPL staff are scheduled for this weekend.

WEATHER: Today: Numerous snow showers along the mountains tapering off in the morning. Snow accumulation up to 2 inches. Elsewhere, mostly cloudy with isolated snow showers. Highs around 30°F. South wind 10 to 20 mph with gusts to 30 mph along Cook Inlet in the morning.
