TIME/DATE OF SPILL: July 3, 2017, 8:30 AM

HOW/WHEN SPILL WAS DISCOVERED AND REPORTED: Alaska Department of Fish and Game (ADF&G) at 8:56 AM.

TYPE/AMOUNT OF PRODUCT SPILLED: The vessel reportedly contained up to 150 gallons of diesel and 25 gallons of hydraulic oil at the time of grounding.

CAUSE OF SPILL: Grounding.

SOURCE CONTROL: None at this time.

RESPONSE ACTION: Locals observed ribbons of sheen and a diesel odor on the water at the scene of the grounding. The Alaska Department of Environmental Conservation (ADEC) is working closely with other state agencies and the United States Coast Guard (USCG) to monitor the incident. ADF&G personnel conducted a flyover this morning and confirmed the location of the grounded vessel. There are active commercial and subsistence fisheries in the area. No fisheries have been closed but ADF&G sent an announcement out to local fishermen advising them to be aware of the incident. Fisherman in the immediate vicinity of the grounding have pulled their nets and the nearby cannery has suspended purchase of fish from the area of the grounding as a precaution.

RESOURCES AT RISK OR AFFECTED: Commercial fisheries remain open in the area. Shorebirds are likely present in the area, seabirds may also be present. Nushagak Bay supports several species of commercially important finfish, such as Pacific salmon, halibut, and Pacific cod. Whales, porpoises, and bearded seals may be present in Nushagak Bay. There have been no reports of impacted wildlife.

FUTURE PLANS AND RECOMMENDATIONS: The vessel owner is en route to the vessel to pump the remaining fuel from the vessel. The ADEC Division of Environmental Health (EH) Food Safety & Sanitation Program have

been notified and have staff in the field. Food Safety & Sanitation Program staff have been in contact with nearby canneries and will be conducting inspections to ensure the safety of the fish product.

WEATHER: Monday: High-62°F, Low-51°F, 50% chance of rain, West winds at 20 knots, seas to 5 feet, patchy fog. Tonight, West winds at 20 knots, seas to 5 feet, patchy fog.

Tuesday: High- 64°F, low-50°F, 10% chance of rain, West winds at 15 knots, diminishing to 10 knots in afternoon, seas to 3 feet, patchy fog.

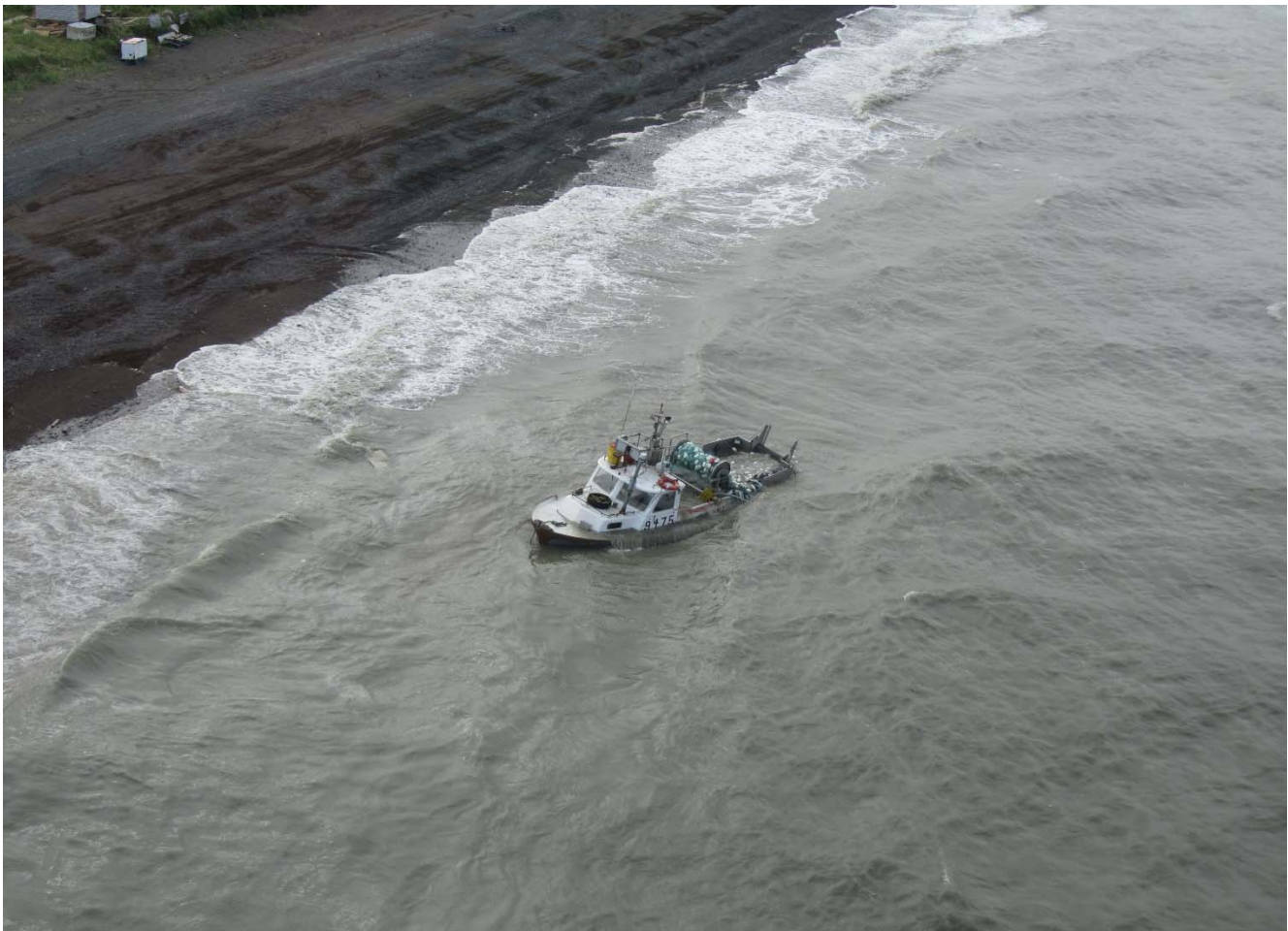
